aving read some past issues of our UMAAS Newsletter - I note that this section seems to be an area where we attempt to extend some "Words of Wisdom" upon each other or to vent on one currently hot topic or another.

Humility prompts me to think I am unworthy of this task but my experiences such as they are indicate that I may be able to provide some comment - so on with the task at hand.....

At the June conference, during our Division break-out and elsewhere, a question seemed to repeat itself about the LGAA program vs. the down in the trenches real world of municipal administration and governance. Some of the questions were of a more technical nature dealing with software training while many surrounded the current lack of more "real life", day to day, operational aspects of the position (if I knew then what I know now!).

My initial thoughts (and responses) were empathy with the persons asking thinking that there could/should be some way to integrate these training needs into one or all of the course modules in an effort to provide those taking it with a more realistic perspective of their chosen field.

Giving this some less selfish second thought I am still convinced

that some "real world" experiences can be provided those taking the program but have come to realize it may not be as simplistic or easy to achieve as first perceived.

Having met with or talked to many administrators from various types and sizes of communities, it is clear that we all do or accomplish many of our day to day tasks from different approaches or means but in most cases with the same net effect or result. That is, we range from a fully automated office environment to still chiselling the minutes on stone. Thus even in the real world there are a number of ways to get to the same point - each as valid or correct as the other. That said each of us could still learn how to deal with some of our day to day affairs particularly when there is some uncertainty or when some of the apples start falling off the cart. Many of us do this already through the miracle of email and telephone with peers. And it is the term "peers" that convinces me that the LGAA program could integrate some of this "real world" into its course content by providing students the ability to engage with a number of administrators on questions of day to day functioning of a municipal office. Now if only administrators had the time to jot a daily diary of all their activities and encounters with little Mrs. Smith who only wants the town to stop the Cottonwoods from

aised in Regina, I was active with helping organize high school and YMCA youth group activities during the late 60's (ah the Porridge Festival.....) and working at the local Brewery during the summer months while attending University of Regina. I obtained my BA/Distinction in Urban Geography in 1975 when I made the tough choice of working in Community Planning field for embarrassingly low wage while gaining "relevant experience" or working at the Brewery for a decent living wage and benefits. Working 27 years with the Brewery, I was active in the Trade Union Movement at the Provincial and National bargaining tables for many years. During the 90's I was seconded by the National Union and

HRSD to provide Layoff and Closure training assistance to food industry workers and employers facing downsizing or closures across Canada. Faced with closure of my own workplace in 2001 I took the opportunity to complete my LGA in 2002 and accepted my current position of Administrator with the Town of Gravelbourg in June 2003. Moving my family (Joanne and 2 high school boys) to Gravelbourg was a frightening challenge but within a month was informed by a resident that my boys had both put their boots on and walked knee deep in cow\*\*\*\* whatever that means. Regardless of what I may feel from time to time the challenges of Municipal Administration are a rewarding and stimulating change sometimes from minute to minute.

## Community Profile - Town of Gravelbourg

eferred as the "Jewel of the Prairies" by Pierre Trudeau, Gravelbourg is located 115km southwest of Moose Jaw. Historically founded as a French settlement by Father Gravel in the early 1900's, the community still maintains a strong connection with its French heritage through various organizations. With a current population of approximately 1200 people - Gravelbourg's key community foundations have focussed on Education, Health and Faith serving a primarily agricultural region in those areas. Gravelbourg currently enjoys both primary and secondary educations in French only, English only and Immersion program streams as well as 2 recent full day-care operations provided in both official languages. Having a regional hospital, Gravelbourg is home to 3 family physicians, chiropractic, physiotherapy, dental practices in addition to alternate treatment and healing practitioners.

Gravelbourg has maintained it's historic architecture to the extent that we boast 3 National Historic Properties (Our Lady of the Assumption Co-Cathedral, its former Bishop's Residence and the former Jesus-Mary Convent which currently houses the Gravelbourg Elementary School. Each of these, along with a number of homes and businesses were built with Claybank brick which makes for an outstanding experience for tourists.

Economic development over the years has seen bursts of population growth and decline but has recently been steadily growing as people move here from various parts of Canada primarily for the safe, peaceful quality of life it offers its residents. With its physical and social amenities, Gravelbourg has become a permanent destination for many.

Gravelbourg is currently home to Trailtech Industries (trailer manufacturing) and Mustard Capital Inc. (Mustard seed processing) which, tandemed with our regional hospital generate significant employment to the community and areas residents.
