## The Learning Curve

here has been a lot of discussion lately on whether the Saskatchewan LGA course provides the required educational material to prepare new administrators to confidently step into their new position which can in some cases be anything from the administrator to a bylaw officer. As a new administrator myself, I do have to agree with the valid points being brought forward regarding the issue. I also can see that such a situation would or will be a long, complicated change that would take many years to implement. With that being said I do believe us new administrators should also take the initiative to educate ourselves as well.

One hot topic I am currently researching is that of Risk Management. Unfortunately our society has changed from being responsible for your own actions to finding someone or something to blame for the situation. As Administrators we are responsible for ensuring the staff, community members and visitors are provided safe environments in which they can carry on their activities.

#### WHAT IS RISK MANAGEMENT

Risk Management involves analyzing, organizing, planning, directing and controlling the resources of an organization to try and minimize the potential chance for and effects of the risk involved in daily operations.

The Process of Risk Management

1) Identify - identify the services and assets that could

was born and raised on a farm in the Vibank area and completed my high school education in Vibank.

I began working for the Village of Vibank as the "clerk" on June 1, 1983 believing this job would be temporary as I raised my children and that when they went to school I would get a "real" job in the city. Little did I know at that time the magnitude of what happens in a municipal office and that I would love my job and 30 years later, here I am.

I enrolled in the Local Government Program at the University of Regina in 1984 and received my "C" certificate in April of 1986 and became the Administrator.

Working in the municipal field was the best decision I ever made. Life is never dull in local government. I have worked with many different Council's in my career and had to learn to change course in the way we operate and yet sometimes direct Council down the proper path. I can honestly say I have never been bored with my job. There seems to never be enough hours in a day to do all the things that need to be done.

A couple of achievements that I am very proud of and played a big part in bringing to Vibank is the creation of the first municipally licensed daycare in the Province, and the Vibank Heritage Centre, formerly a convent, and now housing the municipal office, regional library, daycare and many businesses. This centre, although controversial when

potentially cause financial losses for the municipality.

- 2) Analyze evaluate the risk, the probability of the occurrence, the frequency it could occur, the impact or severity of the loss resulting from the risk, and the length of time it will take to recover from the loss financially.
- 3) Plan assess the options and implement the procedures designed to eliminate the conditions that may lead to loss.
- 4) Monitor Re-evaluate and adjust the plan on a regular basis.

#### SEVEN CATEGORIES OF SOURCES OF RISK

- 1) Physical Environment (snowstorms, floods, etc.)
- 2) Legal Environment (laws & legal precedents)
- 3) Operational Environment (day to day activities)
- 4) Social Environment (special events)
- 5) Economic Environment (market trends, interest)
- 6) Cognitive Environment (attitude of individuals towards risk)

## **Community Profile**

## Village of Vibank

he Village of Vibank is situated approximately 45km southeast of Regina. The Village was incorporated in 1911 and our current population is 374. Not only do we have a newly renovated K-12 regional school that houses many children from the surrounding areas, we also have the first municipality owned daycare in the Province of Saskatchewan. The Village office is located in our heritage centre which was the convent for the Ursulines from 1923 - mid 1980's. As in the past and now in the present the heritage center is still the main staple of our community. It houses the village office, post office, hair salon, library, restaurant (the Grotto featured in many magazines and on the news), the daycare, Judo and Dance club.

Over the last few years the Village has been busy completing a new RO water system which was put on line in the spring of 2012, a new recreation director was hired to help with the operation of the rink and other recreational activities, and renovations are starting on our heritage centre to help it become a more energy efficient building.

Not only do the many programs offered such as Judo, Dance, Hockey, Soccer, Drama, etc. make the community a great place to raise a family. The businesses such as a grocery store, meat market, gas station, restaurants, caterer, bank, license issuer and construction/gravel companies make it a community that is very accessible as well.
